

Frequently Asked Questions

About HDFC ERGO

HDFC ERGO, a 51:49 joint venture between housing major HDFC Limited and ERGO International, Germany (part of Munich Re Group), is the 4th largest private sector general insurer in India and offers all lines of general insurance products including motor, health, personal accident, home, fire, marine, aviation, liability, crop insurance etc. During the financial year ended March 31, 2016, the Company wrote gross premiums of Rs. 3,467 crores and made a profit after tax of Rs. 151 crores. The Company operates through 108 offices across 91 cities.

The Company also has a wide distribution network comprising brokers, retail and corporate agents including Bancassurance besides its own direct sales force. HDFC ERGO has been assigned 'iAAA' rating by ICRA indicating its highest claim paying ability and has been certified with ISO certification for customer servicing, claims and Information Security.

The core values of -HDFC ERGO are **Sensitivity, Excellence, Ethics** and **Dynamism**. 1. Who has acquired L&T General Insurance Company Limited and how much of equity has been acquired in the Company?

Larsen & Toubro Limited has divested its 100% stake in L&T General Insurance Company Limited to HDFC ERGO General Insurance Company Limited on June 3, 2016, vide a share Purchase Agreement. Post receipt of requisite approvals from Insurance Regulatory and Development Authority of India, our regulator and Competition Commission of India the share purchase transaction has been concluded on Sep 9, 2016. Thereby HDFC ERGO General Insurance Company Limited has acquired 100% of the equity of L&T General Insurance Company limited from L&T Limited.

2. Which Government Authority has approved the acquisition?

The approval for the acquisition has been received from the Insurance Regulatory & Development Authority of India (IRDAI) and Competition Commission of India (CCI).

3. What will L&T General Insurance Company Limited be known as, post acquisition by HDFC ERGO General Insurance Company Limited?

Subsequent to this transaction and post necessary regulatory approvals, L&T General Insurance Company Limited is **proposed** to be renamed as HDFC General Insurance Limited (HDFC General). HDFC General will operate as a wholly owned subsidiary of HDFC ERGO General Insurance Company Limited.

4. Will HDFC ERGO General Insurance Company Limited and HDFC General Insurance Limited continue to operate as 2 separate companies or will the two entities be merged?

HDFC ERGO General Insurance Company Limited would shortly be applying to the Bombay High Court for approval of Scheme of Amalgamation of these two entities. It is proposed that the merged entity would be known as **HDFC ERGO General Insurance Company Limited.** The same will be intimated to all policyholders once the requisite court and other regulatory approvals are received. Till such approval is received HDFC General Insurance Limited will operate as a fully owned subsidiary of HDFC ERGO General Insurance Company Limited.

5. How will the acquisition of L&T General Insurance Company limited impact me as the policyholder?

The existing policyholders L&T General Insurance Company Limited can be assured that, as our esteemed customers, you will continue to experience the same personalized working relationships, with high quality of customer service that you have been accustomed to in the past.

Furthermore, policyholders will have access to product suites of both HDFC ERGO General Insurance Company Limited and HDFC General Insurance Limited

6. Will there be any change in policy terms and conditions for me as an existing policyholder of L&T General Insurance Company Limited?

No, there is absolutely no change in your policy terms and conditions.

7. With name of the Company changing does the existing policy document under L&T General Insurance name remain valid or will I receive a new policy document?

All policies issued under L&T General insurance name shall remain so till expiry and do not require any amendments. At the time of renewal a fresh contract with the new company name shall be issued.

8. Will I be able to renew my L&T general insurance policy or will I have to buy a new policy from the new entity?

As there is no change in entity other than the ownership, all renewal related processes remain the same. You would be able to renew your existing policy as per current policy terms. With this acquisition you will have access to products of HDFC ERGO General insurance as well. In case you would like to switch to a new product you can do so, subject to terms and conditions as may be applicable.

9. With the Company being acquired who will pay the claim filed by me as an existing policyholder of L&T General Insurance Company Limited?

You should not be worried about your claim. The Company continues to exist and only ownership of the company has undergone a change. The Company is obliged to settle claims as per the policy terms and conditions. There is no change in claim process, contact details and touch points.

10. Will I be able to make any changes on my policy issued by L&T General Insurance Company Limited?

Policyholders will have no reason to be worried about their policy servicing needs. The Company continues to exist and only the ownership of the Company has undergone a change. The Company is obliged to provide policy related services as per the policy terms and conditions. There are no changes in contact details and touch points.

11. Can I, the policyholder, cancel my policy that was issued by L&T General Insurance Company Limited?

The Company would like to assure policyholders on service quality and there should not be any reason to reconsider their decision just because the ownership of the Company has undergone a change. However, in case you wish to cancel your policy, we would advise you to go through the policy terms and condition as same would apply and thereafter place a request for cancellation by calling our call center or write to us.

12. Will I, the policyholder, be able to continue my No Claim Bonus (NCB) on motor insurance policy of erstwhile L&T General InsuranceCompany Limited which has been earned during renewal?

Yes, the NCB benefits shall continue as per the policy terms and conditions.

13. Will I, the policyholder, be able to continue my Cumulative Bonus (CB) on health insurance policy of erstwhile L&T General InsuranceCompany Limited which has been earned during renewal?

Yes, the CB benefits shall continue as per the policy terms and conditions.

14. Who will service me as a policyholder after the acquisition?

There are no changes in the customer touch point, call center number and email address. Policyholders shall be able to avail any servicing needs through the chosen mode of establishing contact. Refer Contact us page for customer support details.

15. Can I the policyholder buy a HDFC ERGO product from the agents of L&T General Insurance Company Limited?

Channel Partners are allowed to source products from the product suites of both the companies and will now have a much larger bouquet of products to offer to proposers and existing policyholders. Proposers / policyholders can request their agent for any specific HDFC ERGO product they are interested in.

16. Will the existing branch of L&T General Insurance Company Limited in my city be closed or continued as is?

The Company does not intend to close any branch; however, certain branches shall be relocated to a new address. The proposed changes are described in Annexure -1.

17. Will I, as a policyholder, be able to get service from HDFC ERGO General Insurance branch?

Yes, we would be happy to assist you across all 108 branches of HDFC ERGO present in 91 cities. You may seek necessary information of HDFC ERGO branch network at www.hdfcergo.com or call 1800 2 700 700.

18. Will I as an existing policyholder of L&T General Insurance Company Limited be able to access the existing garage and hospital networks of HDFC ERGO General Insurance Company Limited?

Presently, for cashless claim services, policyholders will have to access L&T General Insurance (HDFC General) Insurance network of Garages and Hospitals. We intend to make this network available to both entities in due course.

19. What will be the impact on me as a Policyholder of L&T General Insurance Company Limited post merger?

Post approval from Bombay high court both entities shall be merged into one single entity called HDFC ERGO General Insurance Company limited. There will not be any impact to the policyholders of both entities as their policy terms and conditions, benefits shall remain as was. The merger will bring a unified process and structure, larger distribution and service network and branches. This would mean better reach and service quality to the policyholders. The policy document previously issued would not need any change. At the time of renewal, policyholders shall be issued HDFC ERGO General Insurance policies instead of HDFC General Insurance policies. Any change in communication touch points, details shall be made available on the Company's Website.



20. What range of products does HDFC ERGO General Insurance Company Limited offer?

HDFC ERGO General Insurance Company Limited offers a complete range of general insurance products ranging from Motor, Health, Travel, Home and Personal Accident in the retail segment and customized products like Property, Marine and Liability Insurance in the corporate segment. 21. During renewal is there an option for me as the policyholder for switching from the product of L&T General Insurance Company Limited to HDFC ERGO General Insurance Company Limited before the merger of the two companies or vice-versa?

The option to buy or switch would depend on the product proposed to be bought. All products being offered by both entities shall be available to policyholders of both the companies.
